

# CONTRACT— DRESS AGAIN CONSIGNMENT

- Your dresses will be under a consignment contract for 6 months, which means that you have agreed to leave them here until your contract ends. If your dress is purchased you, the Consignor will receive 50% of the sale price. Dress Again Consignment will keep the remaining 50%
- Dresses brought in for consignment will be checked over for cleanliness, needed repairs, etc. If cleaning or repairs are needed a fee will need paid before the dress will be consigned. Dresses from smoking households will NOT be accepted unless dry-cleaned.
- Should you desire to pick up your dresses before your contract ends, you will be obligated to pay 'Dress Again/The Secret Seamstress' 50% of the asking price.
- You, the Consignor, are agreeable to allowing your dresses to go on sale no more than 25% off in the final 3 months of the consignment term.
- Upon a sale, you will be notified the first week of the following month, and issued a paper check as payment.
- We will advertise your dress via our website and social media, so any photos you have of you in the dress you can send via email so we can use them. Please crop your photos to only include the dress
- You will be issued a card with your final pick up date for items unsold.
- You are welcome to advertise your dresses for sale elsewhere, like FB marketplace, but remember, under this contract a 50/50 split of the sale price is still in tact.
- Unsold items at the end of 6 months *may* be allowed to renew; however, as the consignment business grows terms may be updated
- *Dress Again Consignment* is NOT responsible for any snags, rips, tears, residue, etc. due to trying on and being moved around in our shop.
- *If you do NOT come to pick up your unsold items when your term ends, you are donating them to our shop and have no further ownership or claim to funds if sold*
- The Secret Seamstress / Dress Again is a division of Hat Trick Productions LLC, a Limited Liability Company.
